#### The Barnesville Internet HELP DESK should always be your first call!

Please don't post on Facebook! Each home has a separate fiber line running to the central office - your neighbor can't help but trained staff can - whatever the problem - speed, disconnects, mail problems. Any citywide internet problems will be posted on Facebook.

## BEFORE YOU DIG CALL 811 or 800-252-1166

Before you plant that tree, dig that trench, or build that new garage on your property this season, call Gopher State One-Call.

#### Here's how One-Call notification works:

- Mark the borders of your excavation site with white stakes or white spray paint.
- Be prepared to give the One-Call operator your name, your phone number, your address, the location of your dig site, the type of work you plan to do, and the start date & time of your dig.
- · Call 800-252-1166 or just 811. Gopher State One-Call operators answer calls 24 hours a day, 7 days a week. Weekends and holidays are for emergencies only.
- Utility companies have 48 hours to locate their underground facilities, and digging must begin within 96 hours after calling Gopher State One Call so plan your work accordingly.

#### IMPORTANT FENCE INFO

If you're planning a fence, here are the rules!

- ✓ Fences, including any underground footings must be located entirely on your property.
- ✓ Many lots have utility easements. Fences may NOT be erected on a utility easement. If you're uncertain whether your lot has a utility easement, call City Hall at 354-2292 If fences are constructed on utility easements and there are problems with a utility line, the City of Barnesville will remove the fence!
- All posts used in the construction of fencing shall be faced inward to the area being fenced.
- ✓ The maximum fence height along rear and side property lines is 6 feet.
- ✓ Fences located in required front yards shall not exceed 36" in height except fences that are at least 75% open may be 48 inches.
- ✔ Always call 811 at least 48 hours before you start your fence project to have underground utility lines located. It could save your life.

03-10-25-01 Motion Stokka, second Bergman to approve the agenda as presented. Motion carried.

03-10-25-02 Motion Bergman, second Goedtke to approve the consent agenda as presented. Motion carried.

03-10-25-03 Motion Stokka, second Field to approve the Citizen Participation Plan for the Small Cities Program. Motion carried. 03-10-25-04 Motion Stokka, second Bergman to open the public hearing at 6:38 p.m. for the Small Cities Grant Application. Motion carried

#### DON'T FORGET THE BUILDING PERMIT

Building permits are required for many projects sheds over 120 sq. ft, decks, siding, garages, shingling projects, remodeling, additions and window replacements. Permits are not required for flat concrete work or fences, but if you are adding sidewalk, widening your driveway approach or cutting into the street for new water or sewer services, permits are also required!

You must obtain a permit before starting work. Just applying does not meet requirements.

Permits are issued for a 6 month period. For larger projects, like homes, your permit will be extended for another 6 months. In the case of small remodeling projects, roofing, decks, siding, etc. the 6 month limit applies.

# RUNNING YOUR SUMP PUMP INTO THE SANITARY SEWER IS AGAINST BARNESVILLE'S ORDINANCE!

Not only is discharging your sump pump into the sanitary sewer illegal, but it endangers your neighbors! The sanitary sewer lines, as well as the City's treatment facilities are unable to handle the volume of water that comes from sump pumps, particularly in the case of heavy rain. The result can be raw sewage backing up in homes.

All sump pumps MUST drain outside into the City's storm sewer system. Please make sure your hose runs in your yard, not the neighbors!

Homeowners who fail or refuse to follow the sump pump ordinance are subject to a \$100 a month fine.

#### **Federal LIFELINE Program**



Lifeline makes phone and internet service more affordable for low-income households

#### **INDIVIDUAL ELIGIBILITY**

You qualify for a discount if you participate in any ONE of these government benefit programs:

- Supplemental Nutrition Assistance Program (SNAP)
- Medicaid
- Federal Public Housing Assistance (FPHA)
- Veterans Pension and Survivors Benefit
- Supplemental Security Income (SSI)

- OR -

Your income is at or below 135% of the federal poverty guidelines. See chart on back.

#### **HOUSEHOLD ELIGIBILITY**

A household is a group of people that share income and expenses

- You are only allowed to get one Lifeline discount per household.
- If you share housing, complete the Household Worksheet which is available on the LifelineSupport.org.

#### TO APPLY FOR LIFELINE

The FCC National Lifeline Verifier determines an applicant's Lifeline eligibility. To apply for Lifeline, visit https://bit.ly/lifelineinfo, select your state in the drop down menu, enter your personal information, and after the FCC

National Eligibility Verifier approves your application, contact the City of Barnesville to activate your Lifeline benefits.

MN residents who qualify for the federal Lifeline for telephone service also automatically qualify for a \$10.00/month state Telephone Assistance Program (TAP) discount on landline telephone service. The telephone service must be in the applicant's name in order to qualify based either on household income or the above listed assistance programs. Contact the City of Barnesville for assistance with MN TAP.

## **Alcohol Policy**




