Motorized Scooter Regulations!

Key points of Minnesota laws:

24/7 www.barnesvillemn.com

- Must be 12 years or older to operate a motorized scooter
- Riders under the age of 18 must wear a helmet
- Cannot exceed 15 miles per hour.
- Not allowed on sidewalks.
- Ride as close as possible to the curb
- Must slow to a speed that allows for stopping BEFORE entering an intersection.
- No passengers.
- · Travel in the same direction as traffic.
- · Scooters must be equipped with a headlight and taillight when ridden after dark.

Our community's safety is a top priority. Let's all do our part to ensure our streets and sidewalks are safe for everyone. Officers will be doing their part by stopping and reminding riders of these rules.

Mayor Rick called this regular meeting to order at 6:30 p.m. Member's present were Council members Don Goedtke, Alyssa Bergman, Tonya Stokka, Scott Bauer, and Brad Field. Absent was Council member Dawn Stuvland.

06-09-25-01 Motion Bergman, second Stokka to approve the agenda as presented. Motion carried.

06-09-25-02 Motion Bauer, second Bergman to approve the consent agenda as presented. Motion carried.

06-09-25-03 Motion Goedtke, second Bergman to approve the 2024 audit report by CliftonLarsonAllen as presented. Motion carried

06-09-25-04 Motion Bergman, second Goedtke to approve the resolution authorizing the interfund loan from the Barnesville Municipal utility telephone fund to finance the city public works building. Upon a roll call vote, motion carried.

06-09-25-05 Motion Bergman, second Stokka to approve the CUP for Washwell for an illuminated sign. Motion carried.

06-09-25-06 Motion Stokka, second Goedtke to approve the resolution for a lease for a fire truck, and certificate of incumbency for the Barnesville Fire Dept. Upon a roll call vote, motion carried. 06-09-25-07 Motion Bergman, second Stokka to declare the Clay County Fair a Community Wide Festival. Upon a roll call vote, motion carried.

06-09-25-08 Motion Bauer, second Goedtke to approve the resolution calling for a public hearing on the proposed modification to the redevelopment plan and the proposed establishment of the tax increment financing (TIF) 1-11. Upon a roll call vote, motion carried. 06-09-25-09 Motion Stokka, second Bergman to set Monday, June 23, 2025, at 7:00 a.m. for a public hearing for the vacation of the alley that part of the dedicated alley in Block One, McGrath's 2nd Addition. Motion carried.
